

Planning Area





Size: The entire county encompasses approximately 1,805 square miles.

Location: The Planning Area is bounded by El Dorado County, except for the area under the jurisdiction of the Tahoe Regional Planning Agency (TRPA).

Federal and State Requirements

- RTP Update required every 5 Years
- Evaluate current transportation network for future improvements
- Plan for 0-10 years and 10-20 years
- Account for changes in:
 - Demographics
 - Funding
 - Local, State, and Federal Policies
 - Project Priorities
 - Add New / Remove Completed Projects
- Verify Compliance with Air Quality Conformity Standards



2025-2045 RTP Update



• Vision and Goals

- Policies tailored to our region's unique needs and characteristics
- Aligned with the social and physical conditions in the region

• Framework for Transportation Improvements

- Action oriented
- Short and long-term
- Balanced, comprehensive, and multi-modal transportation system
 - Highways, streets, interregional roadways, public transit, aviation, active transportation, and intelligent systems
- Realistic Funding Plan
 - Projects in the Plan are Eligible for State/Federal Funds
 - Transportation Expenditures Cannot exceed Anticipated Revenues

Environmental Review Process

• What is an EIR?

- An informational document describing the anticipated environmental effects of implementing a project, as required by CEQA.
- Acts as a forum for public participation in the environmental review process.
- An EIR includes Mitigation Measures to reduce potential adverse environmental impacts.
- An EIR does not advocate or promote the project.

- Land Use and Planning
- Noise
- Population and Housing
- Public Services and Recreation
- Transportation and Circulation
- Cumulative and Growth-Inducing Impacts

Next Steps

- Public Draft EIR
 - 45-day public review and comment period
- Final EIR
 - Written responses to comments, and any changes made to the Draft EIR
- Certify the EIR
- Implementing Agencies to Move Forward with Funding, Design, and Further Environmental Review

- Public Scoping Meeting

- Notice of Availability Draft EIR Public Review (45 days)

- Public Hearings EIR Certification/Project Consideration
 - TBD (Estimated Summer 2025)
